Fitch representative Jim Broman, a former fire chief, summed up the district's plight. "ConFire is under resourced," he said. "Even before the station closings you were very, very lean. And you've had to marginalize that even fur-

While short on offering solutions for revenue generation, the Fitch study presented three operational options to the district: keep its current staffing model, deploy a combination of two- and threeperson units, or introduce EMSspecific personnel into the system. Regardless which model is chosen, the study projects that ConFire will be sustainable only until 2017.

"It would be nice if we could run a fire department on statistics alone," said Carman. "But it's not that simple." Carman has formed a committee of labor and management to look at every aspect of the ConFire organization. "We'll go back to the drawing board and build our organization using 23 companies," he said. "The bottom line is, that we will have to operor part of the time, because we simply can't afford to operate all of the stations until our revenue improves."

"We're having to deal with what's being presented to us, not with what we'd like," said supervisor Karen Mitchoff. "The report paints a picture; it gives us options. But the Fitch Report does not solve our problems."

The company plans to fine tune the report and release the first draft to the public Jan. 10.
